Ash Wednesday is the start of the most important time of the year for Christians. It marks the beginning of our celebration of the most vital event of our faith: the death and resurrection of Jesus Christ. The Lenten Season begins with ashes: the ashes of our mortality and sins. To prepare for Christ's resurrection we start with admitting our need for God. Ash Wednesday marks our acknowledgement of the barriers that separate us from God. Humbly we confess and ask God to turn our sins into ashes and seek His guidance in removing the barriers that separate us from Him. The REAL ID Act Comes to MD-What Will It Mean For You?

Need to renew your Maryland driver's license this year? If so, then you should take note that when the time comes you will have to comply with the Federal Real ID Act. The Federal Real ID Act, passed by Congress after 9/11, now requires customers to provide proof of identity, Social Security and Maryland residency documents when completing a transaction. If you do not already have those documents on file with MDOT MVA, you must provide them. All states must follow the federal guidelines, and beginning October 1, 2020, a REAL ID will be necessary to board commercial airplanes and enter federal facilities.

How do you know if you need to submit documents?

REAL ID Lookup Tool: Visit the MDOT MVA's REAL ID Lookup Tool at www.mva.maryland.gov/realidlookup. The Lookup Tool will ask for a driver's license number and advise if you need to bring in the required REAL ID documents.

WHAT type of documentation is needed for REAL ID?

Online Document Guide: If you are required to bring in documents, the MDOT MVA REAL ID Online Document Guide www.mva.maryland.gov/odg will help you identify your 'Core Four' documents:

- One proof of age and identity
- One proof of social security
- Two proofs of Maryland residential address.
- **Make an Appointment:** To expedite your visit, navigate through the online document guide to arrive at an option to make an appointment with a guarantee to be seen within 15 minutes of check-in.
